TRADING TERMS AND CONDITIONS OF SALE

These Terms and Conditions shall apply to all agreements for the sale of goods by the Company to the Buyer and acceptance of delivery of the goods shall be deemed conclusive evidence of the customer's acceptance of these Terms and Conditions.

1. The Company will render an invoice in respect of goods delivered or purchased during the month.
2. All monthly accounts are due for payment by the 20th of the month following date of invoice.
3. Statements will be issued monthly showing aged balances outstanding at statement date.
4. The Company reserves the right to charge interest of 0.05% per day on all accounts not paid by the due date.
5. When a special order for a product outside the Company's normal range is submitted, a deposit may be required which shall be liable to be forfeited if the order is cancelled. The Company also reserves the right to charge part/full payment in the event of no deposit being paid.
6. The risk of goods sold or supplied shall pass to the customer on delivery to his/her/it's premises or vehicle. In spite of delivery having been made title in the goods shall not pass to the customer until the customer shall have paid for the goods in full and no other sums whatsoever shall be due from the customer to the Company.
7. If on delivery any goods fail to correspond with the description or sample under which they were sold or supplied or are defective or unfit for any specific purpose for which they were sold or supplied and the customer notifies the Company thereof within three days after the delivery then the Company at its option shall either replace those goods or credit the customer with or refund to him the price of those goods but, in either case the Company may make a handling charge if the circumstances so justify. Thereafter the customer shall have no further rights whatever in respect of the goods against the Company.
8. The Company reserves the right to stop extending credit and call for full payment at any time.
9. These Terms and Conditions and any matters arising thereunder between the Company and the customer shall be governed by the law of England and Wales.
